A) I hereby allow the unrestricted right and permission to copyright and use, re-use, publish, and republish ALL photographic portraits or pictures, taken by Masterhrxxx on this or any date past or future, of me or in which I may be included intact or in part, composite or distorted in character or form, without restriction as to changes or transformations in conjunction with my own or fictitious name, or reproduction hereof in color or otherwise, made through any all media now or hereafter known for illustration, art, promotion, advertising, trade, or any other purpose whatsoever.

B) I hereby permit the use of any printed material in connection therewith.

C) I hereby relinquish any right that I may have to examine or approve the completed products or the advertising copy or printed matter that may be used in conjunction therewith or the use to which it may be applied.

D) I hereby release, defend, and agree to hold Masterhrxxx harmless, his heirs legal representatives or assigns, and all persons functioning under his permission or authority, or those for whom he is functioning, from any liability by virtue of any blurring, distortion, alteration, optical illusion, or use in composite form whether intentional or otherwise, that may occur or be produced in the taking, processing, reduction or production of the finished product, its publication or duplication, including without limitation any claims for libel or invasion of privacy.
